
Notes

 - a. The amounts directed by the Authority to be recovered by WWU, through the miscellaneous pass-through costs ‘MPt’ term for the regulatory year 2022/23, in accordance with Special Condition 6.1; and
 - b. The aggregate payments made to the SoLRs or LRSP Permitted Assignees in respect of the regulatory year 2022/23.
- 2) Consent was given by the Gas and Electricity Markets Authority pursuant to Standard Condition 9 (Claims for Last Resort Supply Payment) in respect of the above claims on 17 December 2021.

In accordance with paragraph 3 of Standard Special Condition A48 ‘Last Resort Supply: Payment Claims’ WWU increased its transportation charges to such an extent as reasonably estimated to be appropriate to secure that such consequential increase in revenue equaled the specified amount. This was done through an adjustment to allowed revenue in 2022/23 through the MPt term by the total value of claims above of £95,906,397.14.
