
Notes

 - b. The aggregate payments made to the SoLRs or LRSP Permitted Assignees in respect of the regulatory year 2023/24.
- 2) Consent was given by the Gas and Electricity Markets Authority pursuant to Standard Condition 9 (Claims for Last Resort Supply Payment) in respect of the above claims on 20 December 2022.

In accordance with paragraph 3 of Standard Special Condition A48 ‘Last Resort Supply: Payment Claims’ WWU increased its 2023/24 transportation charges to such an extent as reasonably estimated to be appropriate to secure that such consequential increase in revenue equaled the specified amount. This was done through an adjustment to allowed revenue in 2023/24 through the MPt term by the total value of claims above of £26,033,417.00.
